The MN NACNS Board Members voted unanimously to transition our website to a membership software platform. During the time of transition, the domain name, www.mnnacns.org, will be temporarily unavailable. The goal is to have the new webpage up and running by the end of August which will allow time to register for the

fall conference and annual meeting.

The switch is being made because the new software has the ability to manage a website, events, email, and membership rosters while costing less than our current platform. For example, if you register for the fall conference and are not a member, you will automatically

be prompted to become a member or pay the non-member rate. When your membership expires, you will automatically be sent an email reminding you it is time to renew. The board is also hoping the software will provide functionality to enhance our ability to network with other members.

Report from the CNS Educator's Forum and Summit

The 4th Annual CNS Educator's Forum and 16th annual CNS Summit was held in the greater Washington, D.C., area on July 17 and 18. There was a diverse group of nursing leaders in attendance. The 70 attendees represented the American Colleges of Nursing, American Nurses Credentialing Center, American Nurses Association, American Association of Retired Persons (AARP), American

Association of Critical-Care Nurses, Emergency Nurses Association, Oncology Nursing Society, NACNS Board Members and executive director as well as CNSs and CNS educators from across the country. The day was extremely interactive as the goal of the summit is to provide an opportunity to discuss issues that affect the CNS profession with NACNS leadership. Topics included information to assist states working to modernize APRN scope of practice laws, updating the NACNS Core Competencies, and the future of specialty for the CNS.

A few thoughts as I leave the summit.....

Finally, as mentioned in the Spring newsletter, the [CNS Core Competencies](#) are in the process of being updated. One item that has delayed the groups work is the American Association of Colleges of Nursing is expected to put out an APRN competency document for public comment in the coming months. This information will be used by the CNS Core Competency work group. MN NACNS members will be alerted to the start of the public comment period as soon as we are made aware of it.

The final thought I would impart as I leave the summit is a sense of gratitude for the APRNs leading the [Minnesota APRN Coalition](#). There are many states attempting to modernize their APRN licensing legislation and they are using Minnesota verbiage as a model. Our Minnesota affiliate of NACNS has supported and continues to support the important work of the MN APRN coalition.

CNS Census

Three in four clinical nurse specialists (CNSs) specialize in adult health or gerontology, most CNSs work in acute care hospitals that have or are seeking ANCC's Magnet™ Recognition, more than half have nursing clinical-related responsibility for an entire health system, but only 1 in 5 CNSs are authorized to prescribe medications. These are among the key findings of the [second nationwide survey of CNSs](#), conducted by the National Association of Clinical Nurse Specialists.

Cost Analysis Toolkit: A Business Guide for the CNS

Today's health care landscape is ever-changing. Initiatives to improve patient care and safety must take cost savings into account.
